## **BOARD REPORT SUMMARY - Chair & Treasurer Reports combined**

## Key points are:


- There was no change to the Board in 2022.
- We welcomed 4 new employers (FMRC, Graincorp, MAAS Group and CPC) into our Industry Partnership program for 2022, lifting co-op fees to \$25k (\$9k in 2021).
- There were no Alumni or fund-raising functions held in 2022.
- We thank 2 Directors, Suzy Balogh and Andy McConville, who came to Armidale during the year to address a Fellowship and the Rural Focus dinners respectively.
- We raised over \$80k in donations and co-op fees which was matched by a UNEF "Donor Challenge" which resulted in over \$170k in donations, our highest year so far.
- Cash Income from investments plus co-operative fees covered total scholarships and prizes by over \$11k before realised capital losses of (\$14.6k).
- The financial results achieved by UNEF was mixed with income on invested funds achieving a yield of 5.3% income at just under \$44k but incurred Realised Capital Losses of \$14,600 and Unrealised Capital Losses of over \$112,000 reducing the value of funds at market value on 31st December.
- Unrealised capital losses should, hopefully, be recovered, over time. Results in reports are shown at cost value.
- Including realised losses our total cash funds increased by over \$162k.
- We awarded and paid \$49,600 for scholarships & prizes in 2022 from our UNEF accounts plus \$4,000 towards Leadership Training and travel reimbursement for students from our NAB account.
- **BUDGET 2023** Based on the growth in funds and increased support from our Industry Partners for 2023 and using a conservative investment yield of 4% we have lifted total scholarships for 2023 to over \$65k plus \$12k to go towards Leadership Training, work-experience and student travel.
- The Chairman thanked the Board for their great work and support during the year.
- The NSW Department of Fair Trading require financials to be approved at the AGM and a Form A12 to be lodged together with a fee of \$47.

A big thank you goes to our Alumni Donors, who all met their pledges and many have given for over more than 4 years. Their generosity and belief in the College and our cause was recognised by the UNE Foundation this year.

I thank all Directors and members of the SCR for their support, fund-raising efforts and input during 2022. Our thanks also go to the many Officers of the UNE who assist us in UNE Scholarships, Marketing, the Office of Advancement and UNE Foundation and Faculties.

- 1) The Robb College Foundation Association Inc is not required to be audited. It meets the requirements of a Not-for Profit, Community Service entity for tax purposes. For the Fair Trading Commission the RCFA income/expenditure is through and the only assets held by the Association are the NAB Bank account and filing cabinets. All the Robb Foundation Trust Accounts are held by the UNE Foundation for Robb College and do not form part of the RCFA balance sheet.
- 2) The attached Statements and reports show the consolidated Financial Position, Income and Expenditure Report and an analysis of the operations of the RCFA for the year ended 31 December 2022. The results include the consolidated total endowed funds held under Trust by UNEF for Robb College plus the RCFA National Australia Bank account. Accounting method is cash-accounting.

- Due to accounting changes by UNEF, to meet audit requirements which requires all accounts to have a Donor Agreement to receive income, all Prize Accounts were transferred into the RCFA Scholarship account at 30<sup>th</sup> June 2021. All prizes will be maintained and protected by the Scholarship account Donor Agreement.
- All accounts with UNEF except the General account are in the perpetual pool.
- Perpetual Pool funds are invested in shares/equity units.

## 7) Members' Records as at 31st December 2022

- 291 members (14 deceased) had made donations to the Foundation since 1987.
- In 2022 there were 36 Alumni Donors who donated a total of \$95,950.83.
- The average donation was \$2,665 (2021 average for 41 Donors was \$2,470.85, 2020 average for 30 Donors was \$2,261; 2019 55 Donors average of \$2,637 ea).
- At 31st December there was \$12,000 in pledges outstanding, \$2,000 due in 2023.
